Minutes of the meeting held 13th August 2018 at the Community Hall, Ponsanooth.

078/18 Present were; The Chairman Cllr Mrs. M. Ferris, Cllr. Mrs. M. Manetta, Cllr. C. Daly, Cllr. M. Beckett, Cllr. C. Trewern, Cllr. S. Carlyon and Cornwall Councillor Peter Williams.

079/18 Apologies for absence were received from Cllr. Mrs. E. Williams as she is on holiday.

080/18 Declarations of Interests were received from Cllr. C. Daly who is a member of the PPFA and a Planning Officer at Cornwall Council.

081/18 To sign as a true and correct record the minutes of the meeting held 2nd and 5th July 2018.

Proposed by Cllr. Beckett seconded by Cllr. Mrs. Manetta, the vote was unanimous.

082/18 Matters arising; there were no updates to report.

083/18 Reports;

Cllr. Daly reported that things were progressing with the new building, however they have been unable to find the sewage pipes on the field.

Cllr. Peter Williams reported that the roundabout at Treluswell is still being dealt with.

Down towards Stickingbridge, the diversions will soon be cleared up.

Ponsanooth crossing is now included in the Highways plan.

Cllr. Peter Williams to deliver the cheque for the defib., to Cosawes. He felt there should be some recognition for this grant from himself and the Parish Council, perhaps in the Ponsanooth Post and West Briton, however he would leave that to Cosawes.

Cllr. Daly updated the Council re the NDP, the six week consultation has now finished and they have so far received over one hundred replies, next is to create a draft plan.

Traffic and parking are the two main issues on the responses so far.
